- The quotations in prescribed Form-A\* should be addressed to the Director, State Institute of Rural Development & Panchayati Raj, Mizoram: Durtlang Leitan, Aizawl and the envelope containing the quotation should be superscripted with 'QUOTATIONS FOR OUTSOURCING OF MANPOWER' in capital letters.
- Earnest Money Deposit, Security Deposit, Remuneration/Wages, Commission Charge & GST, Responsibility of the Agency, Selection of Firm, Penalty, Agreement and Release of 'Earnest Money Deposit' and 'Security Deposit': All these will be regulated as provided in the "Mizoram Guidelines for outsourcing of Manpower, 2022" vide Memo No.A.12034/1/2019-F.Est dated 10.5.2022.
- 3. All quotations should be signed by the appropriate authority whose name should be written clearly in capital letters.
- 4. The undersigned reserves the right to accept and also to reject any or all the quotations without assigning any reason thereof.
- 5. In the event of any dispute or controversy relating to the service of provisional driver, the decision of the Director, SIRD & PR, Mizoram, Aizawl shall be final and bidding. In case of any litigation, the legal jurisdiction for settlement shall be Aizawl only.
