

TERMS AND CONDITIONS

- Quotationer should deposit 2% of the bid amount as Earnest Money in the form of Bankers cheque / Bank guarantee in favour of Director of SIRD & PR: Mizoram, Durtlang Leitan, Aizawl.
- 2. Quotation without Earnest Money will be summarily rejected.
- 3. Quotationer should quote his/her rate both in figure and in words. Any correction (if any) must be initialed with date failing which the quotation will be treated as invalid.
- 4. The Quotationer or his/her representative may be present at the time of opening of the quotation if he/she so desires.
- 5. The successful bidder should deposit full amount of the offering letter, failing which it will be treated as cancelled and the Earnest Money will be forfeited, and offer will be made to the next highest bidder.
