Mizote hi țawngka leh ziaka Ram leh Hnam hmangaih ber kan ni hial awm e. Social media-ah leh a mihihm thlengin Ram leh Hnam hmangaihna a ri ring țhin. Amaherawhchu, zepnak emaw vawiin thlengin hlawhtlinna tluantling/duhthusam kan la hmu hrigh lo chu a ni phawt mai. Hei hi engvang nge ni ang tiin han inzawt ta ila, a chhanna tur ni awma lang chu ram leh hnam humhalhna tehna/buklung kan neih loh vangte pawh a ni mai thei. Miin ram leh hnama hmangaih leh hmangaih loh chu an thiltih atangin kan teh tur a ni. A tehfung emaw a bukna lung tur rintlak kan buatsaih a ngai hle awm e. Eng vangin maw? Ram leh Hnam humhalh kan tih hian ruihhlo do ringawt hi a ni lo tih kan hriat thar a, kan man fuh hi ava'n ngai tawh tak zet em! Ram leh Hnam humhalh tehna/bukna pawmnahawm tak a awm chuan hmalatute tan hmalak a awlsam ang a, Mizoram dung leh vanga ram leh hnam humhalhna rualkhai (uniformity) a awm ngei ngei dawn a ni. A pawimawh ber zawk chu tu pawh/eng mi pawhin emaw eng hnam pawhin Mizoram hi a hmangaih chuan ring ngam ila. Ram leh Hnam a hmangaih tak tak leh tak tak loh chu a thil tih atangin teh/buk tawh zawk ang u, tiin kan thupuia kan luh chih tak tak hmain a kamkeu nan han ti phawt teh ang.

Ram leh Hnam humhalhna kawnga thil pawimawh em em te chu :

1. Dan zah leh zawm hi ram leh hnam humhalhna kawnga thil pawimawh hmasa ber a ni:

Dan zah leh zawm hi ram humhalhna bul leh atawp pawimawh em em a ni. Ram leh Hnam hmangaihna avangin Dan pela han chet ngaih chang a awm mai thei e. Amaherawhchu, a nawlpuiin dan zah leh zawm țhat mai te hian ram leh hnam kan humhalh țha hle a ni tih kan hriat fuh thiam a ngai. He mi awmzia chu mi zawng zawngin kan phak tawk theuhah ram leh hnam hi kan humhalh thei vek a, kan hmangaih em em vek tih te pawh hi han inhrilh nawn ta ila.

Kan ramin harsatna leh buaina hrang hrang a hmachhawn mek hi a nihna takah chuan dan leh hrai zah loh vang leh zawm lohin a hru chhuah vek a ni ti ila, kan sawi sual lo ang. Dan hi zah ila chuan ruihhlo kan zuar lo ang. Dan loin Mizo hming kan hawhtir lo ang. Dan loin voters ID kan pe chhuak lo ang. Kan eiru lo bawk ang. Thil țha zawk lo chhuah nan Dan hrula chet a lo ngai a nih pawhin thawkaphita lek lam reng chu a him lo tih erawh kan hriat tel a țha ang. Ram leh Hnam humhalhna Dan hrang hrang kan nei nual mai. Article 370 (G) te hi tun ai hian a zau thei ang berin inhrilh nawn in, a zirin inzirtir țha leh ila. A chunga kan sawi ang khian ram leh hnam humhalhna țha ber chu dan zawm hi a ni.

2. Zirna leh Zirtirtu:

Zirna hi kawng engkimah hmanraw pawimawh tak a ni a. Zirna tel lo chuan engkim mai hi a khingbai vek emaw tih mai tura pawimawh a ni. *Malcolm X-a chuan “Education is the passport to*

the future, for tomorrow belongs to those who prepare for today” a ti hial. Zirna hi kan tu leh fate chenna tlaka ram leh hnam lo inbuatsaihna kawng pawimawh tak a ni a. Zirna lungphum țha tak kan neih hi thil pawimawh tawpkhawk a ni. Chutiang thleng thei tur chuan zirtirtu hi an pawimawh hle. Zirtirtu țha chuan ram leh hnam hmangaihna thinlung naupangah leh puitlingah a puttir thei a, hnam dang hmuhsit si lo a, mahni ram leh hnam ngaihsanna rilru leh thinlung puttir theitu a ni. Vawi khat chu hnam dang MZU senior professor pakhat hnenah class lak apianga minute 5 chhung tal chauh, Mizo naupangte hnenah “right attitude” lam hi lo hrilh țhin turin ka ngen a. Chu professor chuan mak a tiin țha a tih zawng tak a lo ni ve chek a ni ang, ka ngen anga a lo tih țhin thute chu min hrilh leh in, lawmthute min hrilh letling zawk hial.

Zirna In leh Zirtirtute hi ram leh hnam humhalhna peng pawimawh tak an ni tih hi kan hriat thar a pawimawh. Ram leh Hnam hmangaih dan dika naupang atanga kan inzirtir chuan nakin zelah ram hruaitu lu ber emaw NGO/CSO vela khaipate an la rawn nih hunah an naupanlaia ram leh hnam hmangaih dan dik, zirtirtuten an lo hrilh țhin kha hman țangkai hunah atakin an bengah a rawn ri chhuak leh ang.

3. Pian pun leh Chhawmdawlina:

Tam ve hrim hrim hi ropuina chi khat leh ram humhalhna tha tak a ni a. Engtin nge kan tam ringawt ang? Hei hi zawhna awm thei tak a ni. Kan inzirtira mahse hlawhtlinna tak tak a la awm chuang hrigh lem lo tih chu kan hre tlang vekin a rinawm. Kan pian pun duh lohna chhan tak te chu ei leh bar zawnna (*phek lehlamah zawnna*)

RAM LEH HNAM HUMHALH

harsat tawh vang te, naupang zirna hautak vang te, damloh hritlana inenkawlna senso tam lutuk vang te, pasal neih har lutuk vang te, nawmchen thlakhlelh lutuk vang te, ruihhlo duh lutuk vang te hi a ni awm e. Hetiang hi kan nih si chuan **kohhran hrang hrang thalaite kum over bituk hi pawt hma deuh hret ila**. Nupui pasal innei mai ila tun ai hian kan piang pung thei deuh ang. Hmeichhiain kum 40 dawnah pasal an han nei a, fa neih tam chu a harsat ve tawh viau ang. Tin, piang pung turin mi kan duh tak tak chuan fa nei tamte chhawmdawlna tha deuh chhawpsak ve ila. Fa pali chunglam neite chu an fate pahnih tal sorkar leh kohhran school-ah BA an zawn thlengin free eduction leh scholarship pek an ni ang tih ni se. Hei bakah hian hmun nei lo pek te, in hmun nei sakna nei lo in sak sak te, tin, sorkar damdawi inah a thlawna nau neih te thlengin chhawmdawlna itawm tham han zawrh thei ila. Hei ai hian piang pung tura inzirtirna te hian awmzia a nei deuh ang.

4. Khawtlang huap pawl hrang hrangte leh tualchhung roreltute ram leh hnam humhalna kawnga an hriatna leh theihna tihpunna Capacity Building & Training buatsaih:

Mi tam takin CB&T hi kan hlamchhiah fo thin. Engvangin nge company lian tak tak hian an budget atangin R&D ah pawisa an thap ngam viau thin kan tih chuan, a rah chhuah tur an hriatlawksa avangin an sum sen zozai chu sum khawhralnaah ngai loin, capital expenditure ah an ngai zawk tih kan hriat kha. Chuvangin, Mizoramah pawh hian ram leh hnam humhalna kawngah YMA Branch OB chin tal te, Local/Village Council te, Tualchhunga eminent citizen te capacity building hi ngaih pawimawh a neih a tul hle. Tin, Law enforcement-te thlengin an capacity building hi ngaih pawimawh theih ni se. Heta trained chhuak lo te phei chu Kumpuan Committee member-ah te hian telh loh ngam ni se. Kumpuan Committee member zawng zawngte capacity build hi a hautak deuh anih pawhin branch tin atangin trainer tur mi 3/4 vel train chhuakin, heng train chhuahte hian mahni branch theuhah training an lo pe ve leh ang, cascading mode in. Ram leh Hnam humhalhna-in awmzia a neih theih nan a ral hmatawng tak takte capacity building hi ngaih pawimawh hmasak berah neih a tul tak zet zet a ni.

5. Ram leh hnam humhalhna tura tehfung neih a tul:

Ram leh hnam humhalhna tehfung ang reng deuh hi kan neih a tul hle. Ram leh hnam humhalh

tih avanga ruihhlo chauh do tumna rilru hi a awm ve thei awm e. A tehfung hrang hrang a awm thei ang. A then chuan ram leh hnam hmangaihnaah hian a tehfung a awm thei lo ti pawl pawh kan awm mai thei e. Amaherawhchu, Mizoram pumah ram leh hnam humhalhna rualkhai zawk a awm theih nan tehfung tha tak a awm ngei a ngai a ni.

6. Mizoram pumhuapa Ram leh Hnam humhalhna thate ropui taka lawm & lawmpuina hun buatsaih:

He tehfung hmanga kumpuan committee hmalakna tha emaw bawhzui tha kan tihte chu sawi hat khawpa lawmna ropui ruahman ila. A lawmman semna hun te thlengin ropui takin buatsaih ila. Hei hian YMA branch hrang hrangah inelna thianghlim a rawn chawk nung ang a, kumpuan committee hmalakna peng hrang hrangte chuan tun ai hian thlawp a hlawh lehzual dawn a ni. Tin, hetiang hian tehfung a awm tawh chuan district hrang hranga kumpuan hmalaknate pawh a inkhairual tawh ang. He tehfung hi kan chhang anih pawhin kan chhannate chuan behchhan rintlak nei se la. Data rintlak tak kan neih theih nan engmah khi rinthuin chhang lo ngam bawk ila a duhawm hle. He tehfung hian in nghahna pawimawh deuh deuh a nei a. Zirna, sumdawnna, dan leh hrai inherilhna, Zu, Damdawi ruihhlo leh a kumpuan committee bik chungchangte an ni a. Hei bak thil tam tak a awm thei awm e. Hei hi a entirna pakhat ah ngai ta ila.

7. Ram leh Hnam tan “Land Ceiling Act”:

Hei hi kan kalpui ngei angai: A khal kan ti talh talh mai thei. A dik a khal, amaherawhchu, ram leh hnam humhalhna kawnga kan tih ngei ngei ngai si a ni. Zawhna awm thei ta chu hei hian eng nge ram leh hnam humhalhna nena inkungkaihna a neih le? A chhan lian tak pakhat chu mahni enkawl sen loh ram zau pui pui kan nei thluah hlawm a, he ram enkawl loh awm mai mai hi thenawm state mipui pung thur thurte khuan an it em em tih hriat a hun hle. Heng ring lo mite neih mai mai tur ai chuan kan rama in leh lo nei lo te tan thehsak turin sorkarin lalet vek se. A hmalama kan sawi tawh ang khan sorkar leh NGO tangrualin ram leh hnam humhalhnaa pawimawh pian pun, tha taka kalpuitu Fa nei tamte chhawmdawl nan, in leh lo nei lo te thehsak turin Land Ceiling Act hi hman a tul viauin ka hria. Hei hi kan ram leh hnam damna tur pakhat pawh niin ka hria.
