India Constitution Article 243-G chuan Village Council-te chu ei leh bara hmasawna (economic development) leh vantlang mipui hmasawna leh intluktlanna (social justice) thlen theihna turin ruahmanna (plan) siam tur leh a taka kalpui (thawk) turin thuneihna leh mawhphurhna a pe. Hemi atan hian Central leh State sorkar scheme hrang hrangte a theih anga thawhpui (converge) leh hmang tangkai turin a beisei bawk. Hetih lai hian India Constitution Article 243-H chuan Village Council-te chu Central leh State Sorkar atanga grants (Central Finance Commission Grants leh State Finance Commission Grants) an dawng bakah chhiah (Own Source Revenue) chi hrang hrang lak theihna thuneihna a pe bawk.

**Village Council-te sumhnar hi hlawm thumin a then theih -** dang (tax, fees, user charge, etc) atanga sum an hmuh hi a ni. Central Sorkar leh State Sorkar atanga sum an hmuh (Central Finance Commission Grants, State Finance Commission Grants, CSS, etc) erawh OSR hian a huam lo. a) Tax revenue (chhiah): property/house tax, profession tax, entertainment tax, advertisement tax, etc.

b) Non-tax revenue: licence fee, rent, permit fee, registration fee, other fees, penalties and fines, user charge, income from investment, interest income, sales and hire charges, market receipts, etc.
