Tun \umah erawh man to si lo, mipuite ham \hatna tur atana sorkarin a duan, man tlawm tak ni bawh si- insurance pahnih, \angkai tak tak kan tarlang dawn a ni.

**1. PRADHAN MANTRI JEEVAN JYOTI BIMA YOJANA (PMJJBY):** Prime Minister Jeevan Jyoti Insurance Scheme tih a ni bawh a, a tawi zawngin, a lawm tawi PMJJBY tih a ni a. Life insurance a nih ang in he scheme leitu chu **engvang pawhin** a boral a nih chuan a rokhawmtu (Nominee) chuan cheng nuaih hnih (2 lakhs) a claim thei a ni.

He Life Insurance scheme zawm tura thil \ul leh he scheme kaih hnawih a thil hriat ngai \henkhatte chu hetiang hi a ni:

- 1) Scheme zawmtu chu India khua leh tui dik tak, Bank account nei a ni tur a ni.
- 2) Kum 18-50 inkar a ni tur a ni.
- 3) Nationalize bank (Sorkar pawmpui bank) khawiah pawh Bank Account a neihnaah a lei theih.
- 4) A scheme zawm/ leina man hi kum khat chung atan Rs 436/- a ni a. (Tax hran chawi belh ngai a ni lo)
- 5) He insurance-in a huam chung (Coverage period) hi kum khat a ni a, kumtin 1<sup>st</sup> June a\anga 31<sup>st</sup> May a ni. Kum laklawhah pawh, eng
