National Survey Office-in a tarlan danin India rama mihring khawpuia cheng za zela 19.1% te chauh hian Health Insurance emaw a tlukpui ham\hatna an nei a. Hemi avang hian India ram a cheng mi nawlpuite chuan inenkawlna senso hi mahnia intum a ngai tihna a ni. India ram khawpuia cheng za zela 19.1% te chuan a chung a kan tarlan hrisel lohna avanga harsatna hi an nei nasa hle. Chung zinga za zela 25.4% te chu damdawi in-a inenkawl ngei ngei ngaite an ni. India ram khawpuia chengte zinga natna tlanglawnte leh langsar zualte chu Lunglam \hat lohna te, Zunthlum te, Thyroid lam \hat lohna, Cancer leh a dangte an ni. Heng natna nei zingah hian za zela 20.8% te hi enkawl vat an nih loh chuan thihpui mai thei dinhmuna ding an ni.

### 1. Cancer:

WHO-in report-a a tarlan hnunung berah chuan India mipui 1.3 billion cheng-ah hian mi 10 zela mi pakhatin Cancer natna nei ang an ni. India mi hriselna lama harsatna neite a\angin Cancer avanga natna hi a sang hle a ni. Cancer natna ah pawh Hnute Cancer a hluar hle mai a, kum khat chungin za zel a 1.4% – 2.8% in a pung a ni.

Eng Cancer pawh lo ni se, Oncology (Cancer enkawlna) senso hi a sang em em a, a tlem berah nuai 5 tal angai in chhut a ni.

### 2. Infertility:

Fa neih theih loh vanga harsatna hi kum 2019 a zirchianna neihah chuan India rama nupa tuak za zel a 14% te hi fa nei theilo/pai theilo an ni a, khawpuia chengah hei hi a tam leh zual a ni. Zirchianna a\anga an hmuh danin khawpuia cheng nupa tuak ruk a\anga tuak khat zel hian fa nei theilo anga hmuhchhuah a ni a, chawhrualin kum khat chungin 10% in a pung ang a chhut theih a ni.

Fa neih theih lohna chhan tur anga lang chu, kan chhehvel boruak thianghlim loh avang leh inthlak danglam (Environmental Toxin) nasat avang te, STI (Sexually Transmitted Infection) vang te, kan nunphungin a zir loh avanga natna hrang hrang (Life style diseases) kan tawh/neih vangte a ni thei.

Naupai tur chuan In Vitro Fertilization (IVF) hmanga pai mai chu a awlsam leh a theih dan awm chhun chu a ni rih mai a. Mahse hemi hmanga naupai tur chuan Health Insurance kan neihte hian a huam tel thei lo \hin a, chumi avang chuan IVF hmanga naupai tur chuan a tlem berah cheng nuai 1 – nuai 2.5 sen angai a ni.

### 3. Congenital abnormalities (Pianpui/inthlahchhawn vanga harsatna nei):

Hetiang lam harsatna neih hi a inang vek kher lo thei a, Khawpuia naupiang hlim thihna thlen chhan pathumna a ni.

Dang kak leh hmuikak hi chu plastic surgery hmanga awlsam taka siam \hat mai theih a ni. Amaherawhchu, a siam hautak dan a zirin a siam man a inang lo a. A tlangpui thuin a tlem berah cheng nuaih khat leh singriat (Rs.1.8 lakh) vel sen a ngai a ni.

### 4. Cataract :

Cataract hi khawvel pumpuia mitdelna thlentun langsar ber a ni a. India ramah he cataract avanga mitdel 17.7 million an awm tawh a ni.

He natna hi Mit lam thiam (Ophthalmologies) in uluk taka a enkawl angai a, A in enkawlna senso hi atlem berah Rs. 55000 atanga Rs.1.2 lakh sen a ngai ni

### 5. Hearing loss (Hriatna hloh/bengngawng/bengchhet) :

Zir chianna-in a tarlan danin India ramah ri hriatna lama harsatna nei hi an tam hle mai a. Delhi bikah mihring za zela 26.1% te hian hri hriatna lamah harsatna neiin, heng zinga za zel 51% phei hi chu engmah hrela khawpa ri hriatna hlohte an ni.

Heng ri hriatna hloh/bengngawng/bengchhet te tana ri an lo hriat ve theihna tur kawng awm chhun chu bengdar khawl vuah mai hi a ni. Amaherawhchu, heng bengdar khawlte hi man tlawm tak a ni lova, atlem berah Rs. 24990/- a\anga cheng nuai 2.7 man te a ni. Heng bengdarte hi a man to hle mahse miin ri hriatna an lo neih ve theihna kawng awmchhun a nih avangin sum sen manhla a ni thei.

### 6. Diabetes :

Khawvel pumpuiah hian mihring 75 million hi zunthlum natna nei an awm a, chung zinga paruk (6) zela pakhat (1) chu India rama cheng an ni. A nihna takah chuan khawpuia mihring chengin he natna hi an nei nasa bik. Diabetes hi natna dang nena inkaihnhawih awlsam bik tak a nih avangin, Diabetes nei mi chuan Lung leh Kal natna neih a awlsam a, a rang thei ang bera in enkawl vat tur a ni.

He natna hi Endocrinologist/Ophthalmologist and Nutritionist-ten an enkawl tlangpui a. An damdawi hman tlanglawn tak chu Insulin Injection a ni.

### 7. Heart disease :

India rama Mihring hrisel lohna thlen thei tam tak zingah Lung lam \hat lohna hi a hlauawm ber te zing a mi a ni a. Kan ei leh in, nunphung inthlak nasat tawh em avangin India ramah mihring 55 million-in lung lam \hat lohna an nei mek a ni.

Cardiology Centre-ah Lung natna enkawl thiam bikin an enkawl \hin a. A enkawl na sum ngai zat hi a tlangpui thu in cheng nuai 1.5 – nuai 4.5 a ngai a ni.

### 8. Infectious diseases:

Tunlai dinhmun ah chuan India rama natna thlentu langsar zualte chu heng - Covid-19, Dengue

leh Malaria te hi an ni a. WHO-in a tarlan danin Dengue natna hi fur lain a hluar hle mai a, I lo kai ve palh hlauh a nih chuan a rang thei ang berin Damdawi in emaw Health Sub-Centre hnai ber pan vat tur a ni. In enkawl ngei ngei ngai si, mahse man tlawm lemlo taka enkawl dam theih a ni. Kum 2019 khan Hyderabad-a Dengue in enkawl na senso ngai zat chu a tlem berah Rs.5000 a\anga Rs.5 lakh a ni.

### 9. Hair Loss:

Samtla leh chalsam tla kawlh hi mi tute pawh in neih theih a ni. Naupang a\anga puitling, mipa leh hmeichhia thlenga harsatna awm thei a ni a. Chhan hrang hrang vanga thleng thei a ni. A chhan lian tham ber ni a lang chu rilru hah/sen nasat vang a lo awm thei a ni. India ramah kum 2018 kum laihawla report tarlan dan chuan Mipa kum 20 chunglamah a hluar hle a. He harsatna hian rilru leh taksa a nghawng thei ve ve a ni.

A enkawl na awm thei pakhat tarlan chu Hair Transplant a ni. He Hair Transplant tih nan hian sum Rs.30000/- – Rs.1.35 lakh vel zet sen a ngai.

### 10. Obesity (over weight):

India ram khawpuia chengte zinga hrisel lohna thlen thei zingah hian Obesity hi a hluar hle mai a. Nunphungin a zir loh vanga he harsatna hi lo awm a ni. Hemi avang hian taksa-ah harsatna leh natna hrang hrang a awm phah thei. Zirchianna in a tarlan danin India ramah kum 2030-ah chuan khawvel pumah Naupang hetiang ang harsatna neih ah hian dinhmun pahnihna hauh thei turah a dah a, 27 million zet an awm tura chhut a ni. Kum 2040-ah chuan puitlingin he harsatna hi a let hniha nei tura ngaih a ni. He harsatna hi ngaihthah chi a ni hauh lova, a enkawl na atana \ha ber chu taksa zang tura insawizawi \hat leh ei leh ina fimkhur hi a ni deuh ber.
