

Dan hriat loh hi chhuanlam tling a ni lova. Mi zawng zawng hi kan ram Dan hre vek tura ngaih kan ni. Chutihlai erawh chuan a nawlpua thlirin Mizote hi Dan hriatna lamah kan la mawl mang em em a. Sawrkar hna sang tak tak thawkte zingah pawh Advocate leh Magistrate hna la hre hrang lo pawh kan kat nuk mai.

Tin, chumai bakah Mizoten Dan kan hriat dan hrim hrim pawh hi a dikhlel em em a. Kristianna kan hmelhriat tan dan hian kan rilru leh ngaihtuahna min kaihruai thui deuh nge, Mizote hian tun hma atang tawha vawiin thleng hian Court nena inhnamhnawihna neih hi kan hreh em em thin a. A theih chen chenah pumpelh dan hram kan zawng thin.

Mi tam tak chuan Court hna hi hna tawmkailo, Sakhuana nena inmihran hlak, mi tawngthei leh dangchakte dinchanna mual ni anga ngai pawh tun thlengin thahnem tak an la awm nawk awm e. Hei hi a chhan ni bera lang chu Court hi misualte hremna hmun ang chauha kan ngaih vang a ni a. Thubuai neite chetvelna emaw chauh ni-a, thubuai laka kan himna hmun zawk a ni tih kan hmuh hmaih fo thin vang zawk niin a lang. 'Mi thenkhat chuan kum hei leh chen ka dam tawh a, ka nunah Ukil mamawhna a la awm lo' tiin insawitheihnan kan hmang thin a. A nih leh 'Kum heti zat ka dam tawh a, Doctor vawikhatmah ka la rawn miah lo' ti ta ila, mi fing, taksa hriselna ngai pawimawh mi nge kan nih ang, mi ngaihsam leh inenkawl uluk vak lo, ngaihtuah chian ngai tak chu a ni

Chutiang chu kan dinhmun vel a la nih avangin Mizote hian Dan hriatna lamah tan kan lak thar hi a ngai nasa hle tih a langchiang em em a. Dan hi Pathian thu nena inrem thlap, mipuite him tlan zawkna atana siam, mi chaklo zawkte khaichuaka, an dikna leh chanvo haichhuahna hmanrua a ni tih hi kan hriatchian a tul hle!

Kan taksa a lo hrisel zawk theih nan mihring dam tha pangngai pawhin a khat tawka in check up an mamwh thin ang hian nakina buaina kan la pumpelh theih nan mitinte hian Dan hre mi, Ukilte hi kan rawn vat thin a pawimawh em em a. Khawvel thiamna leh hmasawnna thang chho zelah engkim hi fimkhur tak leh uluk taka kalpui a ni deuh vek tawh a. Thil inlei, inremna siam, pawisa inpuk tir leh heng kaihhnawih zawng zawngah te hian Ukil te hriatpuina tel lo chhuan Court chuan pawmtlakah a ngai tawh meuh lo!

Chumi a nih vang chuan mitinte hian nakina buaina kan pumpelh a, 'Se bo hnua se kawngkhar' an sawi ang maia puih theih kan nih tawh loh hnua puih ngaia harsatna namenlo tak kan tawh loh nan, kan aiawh Lal hmaa ding 'Ukil' te hi pan vatna chang hre thin ila, chutichuan nula fing, khawnvartui keng an sawi ang mai khan nasa takin kan kawng kan lo sial lawk tihna a ni mai dawn a ni. Keimahni tan vek tho a ni e.

Mi tam tak chuan kan dikna kan hriatchian tawk loh avangin kan diknaah pawh nasa taka rahbehin kan awm phah thin a, a pawi em em a ni. Mipuite dikna leh chanvo auchhuahpui turin mi zawng zawngte hmaah kan au chhuak thei si lo. Chuvangin, mi chanhai leh rahbeha awm ten an dikna leh chanvo an hriat a, mipuiten Dan hriatna lama beng

kan chhit lehzual nan tiin he 'Booklet' pawh hi tihchhuah a ni a. He Booklet tlawm tak hi mitinte Dan hriatna kawnga kan mit ti keutu a lo nih ngei theih nan chhiartu zawng zawngte duhsakna sang ber kan hlan e.

Khawvel hmun dang ang bawkin Mizoramah pawh Information Technology (IT) hmasawnna avangin Mizoten computer, smart phone leh internet te kan hmelhriat ve ta hle a. Chu'ng avang chuan social media te leh e-commerce website te pawhin kan nitin nunah hmun a luah thuk ta hle.

Eng thil pawh hian thatna leh that lohna a nei vek a, IT pawh hi chutiang tho chu a ni. Thatna leh tangkaina tam tak nei mah se, that lohna tam tak a nei ve bawk. Chutiang a nih avang chuan fimkhur ngaihna lai inzirtir hi a pawimawh lehzual ta hle a ni.

‘Cyber Crime’ tih chu IT hman khawlohma avanga dan bawhchhiatna sual hi a ni a. Cyber tih hi computer leh internet chungchang sawina a niin, ‘cyber space’ kan tih chuan computer leh internet khawvel tihna a ni a. Chu ‘cyber space’ chhunga dan bawhchhiatna chu ‘Cyber Crime’ a ni.

India ramah chuan Cyber Crime chungchanga dan kan neih pawimawh ber chu IT Act 2000 a ni a. IT Act mai bakah hian a tul a nih chuan Act dang te pawh tlawhchhan a ni thin bawk.

DAN KALH THIL TIH LOH TURTE: Hriat loh vang leh hre reng chunga tihsual hi dan hmaah chuan thiam loh chan theihna ve ve a ni a; chuvangin, IT hmangtute hi kan fimkhur a ngai a ni. Kan fimkhur ngaih zualna te tlem te chauh han tarlang ila:

1. Mi khawl (computer, mobile, etc.) te a neitu phalna lovin khawih ngawt tur a ni lo va, IT Act Section 43-na hmangin thiam loh chantir theih a niin, kum 3 thleng jail tantir leh/emaw, Rs. Nuai 3 thleng chawitir theih a ni.
2. Social Media-a fake account siam hi dan kal a ni a, mi tam takin dan kalhah pawh kan ngai lo mai thei. IT Act Section 66C hmangin hrem theih a niin kum 3 thleng jail a tantir leh/emaw, Rs. Nuai 1 thleng chawitir theih a ni.
3. Saruak thlalak/video te hi a neitu phalna ni lovin thawn darh theih a ni lo va, ruang thlalak thawndarh pawh hi dan kah tlat a ni. IT Act Section __ hmangin hrem theih a ni a, kum 3 thleng jail a tantir leh/emaw, Rs. Nuai 5 thleng chawitir theih a ni.
4. Danin thiam loh a chantir ni lo va, mi ‘a eiru’, etc. tia social media-a comment-tu hi hrem theih a ni a. IPC Section 499 hmangin kum 2 thleng jail tantir leh/emaw, pawisa chawitir theih a ni.
5. Social media-a sakhaw dang sawichhiat hi thil pawi tak a niin danin a phal hauh loh thil a ni. IPC Section 153A hmangin kum 3 thleng jail tantir theih a ni.
6. Invauna (tualthat, etc.) hi dan kah tlat a ni a. IPC Section 506, 507 hmangin hrem theih a niin kum 7 thleng jail tantir bakah pawisa chawitir theih a ni.

INVEN DAN TUR: A chunga kan tarlante khi chu keimahni thil tih dik loh vanga hremna kan tawrh theih te a ni a. Keimahni dik loh vang ni miah lovin misual kut tawrh a awlsam hle a, chutiang a nih avang chuan inven dan tlem, mi nawlpuiin kan hman theih leh zawm nghal mai theih tur han tarlang ila:

- 1. Username/ID & Passsword:** Username/ID leh password te hi khawiah mah ziakin dah tur a ni lo va, rilrua vawn tlat tur a ni. Website hrang hrangah password hrang hrang hmag thei ila a tha hle. Tin, password hi midangte tana min ‘risk’ sak awlsam hman tur a ni lo a ni. Entirnan: Mahni pian kum, phone number, ngaihzawng/nupui/pasal te hming, etc. Password-ah hian thumal bakah special character (!,@,#,â,1,2,3...,etc.) te telh thin tur a ni a. Tumah (eng anga kan mi rin pawh) kan password hi hrilh loh tur a ni.
- 2. Website Rintlak Loh:** Website nazawngah hian in-register/sign-up ngawt loh tur a ni. Mi tam takin website hrang hrang login atan username leh password inang an hman fo thin avangin website rintlak lova in-register ngawt hi a pawi thei a ni.
Tin, misual thenkhat chuan website lar deuh lem an siam chawp thin a, chutiangah chuan mi login turin an bum a; tichuan, an username leh password an hriat ruk sak a. Website dik tak zawka account neitu account te kha an khawih chingpen ta thin a ni.
- 3. Dawta Inbumna:** “Chumi, khami chuan pawisa tam tak a thihsan a. Chung pawisa chu dawng turin i phone number hmang hian thlan i ni a..., etc.” Hetiang message hi mi tam takin an dawng thin.

Social media kaltlangin sap tlangval hmel̄ha tak angin account an siam a, anmahni ngaisang tur awm an ngaizawng der a. “Present ka lo thawn che a... In ram custom-ah a tang a. Pawisa hemi account-ah hian a lo thawn mai la...” Hetiang pawh hian mi an bum fo Ქthin. Mizo ngei pawh hetiang hian bum tuar an lo awm nual tawh a. Pawisa tam tham tak chan te pawh an lo awm tawh a ni. A pawi hle.

4. Mobile Application: Mobile app reng reng official Play Store/App Store aṭanga download hi a him ber a. Installation file (.apk, etc.) aṭanga install hi a him lohna hrang hrang a awm thei a ni. Installation file-ah khan misualin thil dang an phum ru em tih hriat a har tawh a, official store aṭanga download erawh anmahni (official – Google, Apple)-in an check vek a nih avangin a him nge nge Ქthin. Misualin installation file-a thil (a hmangtute tana pawi thei tur) an lo phum ru palh a nih chuan a hmangtute tan hriatchhuah mai ngaihna a awm si lova, harsatna a thlen thei a ni.

5. Software Pirate Loh Hman: Software zawng zawng hi lei ngai a ni hauh lo va. Software Ქthenkhat chu a ‘free’ a hman theih tur tam tak a awm a ni. Mahse chutiang ni lo, a siamtuin hlawkna a hmuh ve theihna tura software a siam, lei ngai tam tak a awm a.

Software pirate hman hi a hmangtu tan, dan kalh a nih bakah, a him lo fo. Mi Ქthenkhatin software crack-na tur te an siam a, internet-ah download theihin an phochhuak a. Mahse, chutiang crack-na hmanga software crack chu a him lo fo Ქthin a ni. Hetiang software crack-na hian software a crack bakah thil dang pawi a khawih thei fo Ქthin

a, virus kaina awlsam tak a ni. Virus hian keimahni min tihbuai piah lamah kan hriat miah lovin, hna a thawk thei a, chu tak chu a hlauhawm lai zawk tak pawh a ni nghe nghe.

6. **Software/OS Update That:** Software leh Operating System (Windows, etc.) kan hman te hi update a awm chuan update thin tur a ni. Software pirate erawh update dawnin buaina a awm fo thin. A bik takin OS update hi a pawimawh zual a. OS update a nih hian keimahni min tibuai theitu virus, etc. laka him lo kan OS te kha a siamthatna dah a ni thin a ni.
7. **Antivirus Software Hman:** Antivirus software hi a free eng emaw zat download mai tur a awm a. Mahse, a free hian harsatna rin loh tak a thlen fo thin. Virus kai file kha a hmangtu hriat lova lo delete mai te pawh a awm thin a, buaina a thlen ve thei a ni. Chutiang a nih avang chuan antivirus software hi lei ngai ngei hi a tha zawk tlangpui a. Antivirus software ngei pawh hi update a ngai thin a, chu chu ngaihpawimawh tur a ni. Virus a chhuak thar reng a, chung a chhuak thar hmachhawn thei tur chuan antivirus te hi update a ngai thin a ni. Tunlai antivirus software thaah chuan virus do letna tur chauh ni lovin Firewall te leh thil dang te pawh a keng tel thin a ni.
8. **RUKRUKNA CHUNGCHANG:** Mizorama computer kan hman tam zawka Windows hi dan anga neih ni lo, a ruka kan ruk a nih a rinawm. Thenkhat phei chuan an ru a ni tih pawh an inhre kher lo mai thei, a hria te pawhin dan ang tak a lei dawna to an tih avangin an ru fo niin a ngaih theih.

Chutiang bawkin kan zaithiamte hla pawh kan ruksak nasa hle. Zaithiam nih hi mi ramah chuan hlawkna a tling a. Keini ramah chuan eizawn nana hman a har hle. Mi zai (audio file) ruk hi kan ramah chauh pawh ni lovin khawvel pumpuiah a hluar hle a. A tih tawp mai dan hria pawh an awm lo niin a lang. Chutiang khawp chuan he thil sual hi ven a har a. Dan anga na taka hrem theih a nih laiin mi tam tak chuan hrem hlau hle siin ruk erawh an hlau lo hle niin a ngaih theih bawk. Keini Mizote tan chuan he ngaihdan leh kan sakhuana (Kristianna) inzirtirna hi a inkalh tlat nghe nghe a ni.



Mi thlalak, video, thuзиak, etc. te hi kan thehdarh duh a nih pawhin a ruk a rala ti lovin a neitu remtihnain thehdarh thei ila, a thehdarhtu tan pawh rilru nuam takin a tih theih ang a, a neitu tan pawh a lawmawm zawk ngei ang.

Dan hi mitinin zah ila, danin min phut angin awm theuh ila, harsatna tam tak hi a kiam ngei ang.

Human Trafficking Lak ata Engtinnge Kan Hmeichhiate Kan Venhim Ang?

Tunlai khawvelah hmeichhiate rukbo leh hrallh thawm hriattur a awm ta zeuh zeuh a. Chung lak ata engtinnge kan hmeichhiate kan venhim theih ang tih i lo zir ho dawn teh ang u.



Human Trafficking awmzia:

Human Trafficking tih tawp chuan a huam zau hle a. A tawi zawnngin Dân lo a mahni mihringpuite hmanga sumdâwnna hi ‘Human Trafficking’ chu a ni. United Nations-in a hrilhfiah dân chuan, “Bumna te, vauthaihna te, tharum te, thuneihna hman sualna te leh chak lo zawk an nih avânga mite chhiatna tûra hna lâk, hnathawk tûra thawn, chhawr, dawnsawnte leh tawktarh leh lawmmman eng emaw siama mi dangte tihchhiatna zawng zawng hi Human Trafficking chu a ni.”

IPC Section 370-na chuan hetiang hian a sawi a, “Mite tih chhiat tum ran chunga hna lâk, hnathawktu tur thawn (transport), chhawr, sawn kual leh dawnsawn te hi phal a ni lo a, chutiang chu miin vau-ঢাইনা emaw, tharum leh tihluihna hmang emaw, rûk bo leh bum chhuah hmangin emaw, thuneihna hmangin emaw, tawktarh eng emaw hmanga a ti a nih chuan mihring hmanga sumdawnna (offence of trafficking) a ni.”

Human Trafficking huam chin:

(1) Kut hna thawk tûra lei leh hrall: Thiamna leh finna kawngah mihringte kan sang tawh viau emaw kan tih laiin mihringte dikna leh chanvo rapbeta sal chhawra inchhawrbeh sawi tur leh hriattur hi a lo la awm leh zeuh thin a, A bik takin ram hnufual te zingah a hluar zual emaw tih theih tur a ni a, hetianga kut hna thawk tura inchhawr luih hi dan chuan a khap tlat a ni.

(2) Nawhchizawrhna: Nawhchizawrhna hi khawvela profession upa bera sawi thin a ni a. Kan Bible ah meuh pawh khan hmeichhe inzuar hriat tur an awm a ni. An duh thua hmeichhe inzawrh ngawr ngawr hi chu Dan hian a khap bet lem lova. Amaherawhchu, sum hmuhnana hmang an remtihna emaw an duhlo chung emaw Nawhchizawrhna khura hnuhlüh hi Dan chuan a khap tlat a. Sual rapthlak takah a ngai a ni.

(3) Taksa peng hrang lei leh hrall: Tunhnaiah mihring taksa peng hmanga sumdawn hi a hluar hle mai a. Mi nung tha laite an hriat lova an taksa peng ruk sak thawm hriatturte pawh a awm ta zeuh zeuh a. Hetiang hi human trafficking diktak a ni a. Dan chuan a ngai thutak hle a ni.

Engnge a chhan, engtinngé kan inven ang?

Human Trafficking hluar chhan bul ber pakhat chu retheihna vang a ni. Kan retheihna vangin sum thawk chhuak tura kan vahchhuah a ngai a. Thiamna bik kan nei te a nih lem loh phei chuan chuti maia awlsam leh hlawk hna pangngai thawh tur a lo awm lutuk si lova. Chu chuan bei a ti dawngin rual a ti awt a. Ngaihsamna leh pawisaklohma a hring chhuak a, a tawpah kan duh loh deuh thangah min awrh tir leh phah thin a ni.

He pawikhawihna laka ata invenhimna tha ber chu mahni intodelh a ni a. Midangte pur buai leh an thuhnuiaia awm lo thei tura mahni dinhmun lo siamrem thiam hi a pawimawh em em a ni. Amaherawhchu, chhungkaw dinhmun azir vangte leh chhan hrang hrang vang tea rahbi a pelh chhoh chuan midangte purchaw loh theih loh chang a awm lo thei lova. Mahni inlum chhuahsana ramdanga ei kan dap mai a ngaih changte pawh a awm thin.

Chutiang dinhmuna kan ding a, Phaia hna kan zawng dawn a nih pawhin a pawimawh hmasa ber chu kan zuk kalna tur leh kan zuk thawnha tur hmun zuk hriatchian hmasak a, rintlak a ni dawn em tih lo finfiah hmasak hi a ni. Chumi atana pawimawh em em chu Mizo Welfare hruaitute thurawn laka thiama zuk biakrawn nachang hriat a ni. Mi tam tak chu duh aiin Vairam kan ngam mah mah thin a. Mizo Welfare te biakrawn tul ti lo leh inhriattir duh lo, zuk pawngpaw basa ngam kan awm leh zeuh thin a, a pawi khawp mai!

A bik takin hmeichhia te phei chu taksa thaaw awmnem zawk an nih avangin hnamdangte zuam leh ngam an hlawh



duh bik em em a. A tirah hna tha tak tiamin an thangah an khalh lut tial tial a, a tawpah talchhuah leh theih tawh lovin an awk

ta mai thin. Chung zawng zawng pumpelh nana pawimawh chu kan awmna hmun tur hriatchiana Mizo Welfare te thurawn lak thiam a ni. A tawi zawngin mi nazawng rin loh a him ber!

Tin, hmeliat lohte nel dan tawk leh rin dan tawk kan thiam a ngai a. Fin ve kar tur a ni. Mi tam tak chu sum leh pai tawktarh a nih vanga rilru fim hmang thei lova buai chhe ta mai sawi tur an awm leh zeuh thin a. A sawhkhawk tur pawh an ngaihsak chang tawh lo thin! An awmdana rinhlehawm, heti lampang sumdawnnaa inhnamngawih ngei ni-a kan hriatte chu ngaiwh bopui mai lova a rang thei ang bera Police hnena kan thlen vat thin hi a pawimawh em em a. ‘Thir chu a lin laiin deng rawh’, tih a nih angin chung pawimawhte chu a rang thei ang bera Police hnena kan report vat hi a pawimawh em em a. A sarhu laia sawichhuah a nih loh chuan a thamral thuai a, sual ti ngampa tawk vel lekin a zuzi mai thin. A pawi takzet a ni!

Eng nge a hremna?

Human Trafficking kaihnawiha hremna Indian Penal Code (IPC) hnuaia awmte sawi leh thuak thuak ila.

(1) Mi rubotu chu kum sarih (7) thleng tantîr theih a niin pawisa chawitîr bawk tûr a ni [Section 363 of IPC]

(2) Kut dawhtîr tûra mipa naupang kum 16 hnuai lam leh hmeichhe naupang kum 18 hnuai lam ru botu chu kum 10 tantîr theih niin pawisa chawitîr bawk tûr a ni a, ru botu hian naupang chu kudawhtîr tuma a taksa pêng a tihchhiatsak (maiming) a nihphei chuan pawi khawihtu chu dam chhûng tantîr tûr a ni a, pawisa chawitîr bawk tûr a ni [Section 363A of IPC].

(3) Pasal neih luihtîr tuma hmeichhe ru botu chu kum sawm (10) thleng tantîr theih a niin pawisa chawitîr bawk tûr a ni [Section 366 of IPC].

(4) Hmeichhe naupang kum 18 hnuai lam mi dang nena mipat hmeichhiatna hawi zawnga hman tûra hruai chhuaktu chu kum sawm (10) thleng tantîr theih a niin pawisa chawitîr bawk tûr a ni [Section 366A of IPC].

(5) Human Trafficking-a inhnamhnawih chu hrehawm taka kum sarih (7) aṭanga kum sâwm (10) thleng tantîr tur niin pawisa chawitîr bawk tûr a ni [Section 370 (2) of IPC].

(6) Human Trafficking-ah hian mi pakhat aia tam thawn leh sawngbawl an nih chuan pawi khawihtu chu hrehawm taka kum sawm (10) aia tlem lo tantîr tûr niin dam chhûng tantîr theih a ni bawk a, pawisa chawitîr bawk tûr a ni [Section 370(3) of IPC].

(7) Pawi khawihna tuartu hi kum tling lo a nih chuan pawi khawihtu chu hrehawm taka kum sâwm (10) aia tlem lo tantîr tûr a niin dam chhûng tantîr theih a ni bawk a, pawisa chawitîr bawk tûr a ni [Section 370(4) of IPC].

(8) A tuartu hi naupang kum tling lo pakhat aia tamkum 14 aia tlêm lo tantîr tûr niin, dam chhûng tantîr theih a ni a, pawisa chawitîr bawk tûr a ni [Section 370(5) of IPC].

(9) Kum tling lo laka Human Trafficking pawi khawihna avânga hremna pêk tawh, hrem nawn ngai an awm a nih chuan pawi khawihtu chu dam chhûng, a thih thlengin tantîr tûr a ni a, pawisa chawitîr bawk tûr a ni [Section 370(6) of IPC].

(10) Sawrkar hnathawk emaw, Police Officer emaw hetiang pawi khawihnaa inhnamhnawihte chu dam chhûng, a thih thlengin tantîr tûr a ni a, pawisa chawitîr bawk tûr a ni [Section 370(7) of IPC].

(11) Human Trafficking tuartu kum tlinglote chu hre reng chung emaw, pawi khawihna tuartu an ni tih ringhlel chung emawa mipat hmeichhiatna lam a miin a lo chhawr a nih chuan a chhawrtu chu hrehawm takin kum nga (5) aṭanga kum sarih (7) tantîr tûr niin pawisa chawitîr tûr a ni bawk [Section 370A(1) of IPC].

Khawvel ram hrang hrang Constitution nena enrem a nih tlat avangin khawvela Constitution chhuanawm leh rintlak berte zinga mi a ni hial ang. Chu Danpuiah chuan khua leh tuite hian Dikna leh Mawphphurhna thahnem tak kan nei a. Heng kan Dikna (Right) leh Mawphphurhna (Duty) te hi kalkawp tlat tur an ni a, a khawi zawk zawk pawh lakvunga, thlauhthlak bik neih a thiang hauh lo!



Fundamental Rights Kan Tih Hi:

Fundamental Rights tih chu a tawi zawngin dikna lungphum tihna a ni a. A awmzia berah chuan India khua leh tui bikten kan dikna chanvo humhim a nihnaa ram Danpuuiin min venhimsakna tih pawhin a sawi theih ang. Kan ram Danpuia Part III an tih mai, Fundamental Rights reng reng hi mi tupawhin an bawhchhiata kan chungah hleilenna reng reng an siam chuan thil serious tak anga ngaih a ni a. Keini, hnam naupang tak leh kan phai vai hnampui, hmakhawsang ata tawha khawvel finna lo tem hmasa tawh tute nena intliarna awm map lova dan pakhat tlawhchhanna hnuaihnaa dikna thuhmun kan neih ringawt pawh a lawmawm tawh tehreng nen Fundamental rights tho Art 15 ah keini ang hnam hnuaihnung leh naupang zawkte tana a tha lama duhsak kan hlawh bikna tur thu kan hmu leh a. Clause 4 ah phei chuan chhiarsen a ni lo. Tin, chumai a la ni lo cheu Art. 16 ah keini Zofate leh hnam hnuaihnung zawkte tana sawrkar hnaah thleng seat hauhsak bik tura dikna kan la hmu

leh fo bawk a. A ropuiin a lawmawm tih mai loh chu sawi tur dang a awm lo.

Art. 19 ah hian India khua leh tawh phawtte chuan India ram chhunga zalen taka kalkual phalna Right kan nei a. Righth to live with human dignity:

State of Maharashtra v. Chandrabhan, Hemi case ah hian Supreme Court chuan Bombay Civil Services Rules, 1959 ina sawrkar hnathawk hremna tawk mekte hnena hlawh tlem uchhuak tak an pek thin chu Art.21 a kalh tiin an hnawl sak a. Nung tura dikna kan neihna hian, nunna tura mamawh tinreng phuhrukna pawh a keng tel tiin an tlip zui a ni. Hei hi zau tak paw`n a hrilhfiah theih a, Entirnan: leiba rulh duh loh te, hlawh pek that duhloh te, rilru na deuha insiamte hi Art.21 bawhchhiatnaa ngaih vek a ni.

Right against illegal detention:

Joginder Kumar v. State of U.P., Mana awm, Joginder Singh chu mana a awm thu police ten a chhungte hriattir lova ni 5 lai an hren avangin, misuala puh, Jiginer Singh chu Supreme Court ah a zualko a. Court chuan lo ngai thutak hlein, hetiang hian police ten mi an man reng renga an zawm ngei ngei tur thil an duangchhuak ta nghal a:

Police in mi an man dawn reng rengin, man a nih thu a chhungte emaw/a thiante hriattir/hrilh kan khapsak tur a ni lo/kan phalsak tur a ni. Police officer in an mi mana hnenah man an nih chhan leh, Court a an kalpui hun tur diktak a hrilhawlk thin tur a ni. Police officer chuan an mi mana chu, man a nih dan kimchangin chiang takin ziakin a chhinchhiah tur a ni.

Right to Free Legal Aid:

M.H. Hoskot v. State of Maharashtra, Misuala puh, mana awm Mr. M.H. Hoskot chu retheihna avangin a Court hmaa a thiamthu sawisaktu tur Ukil rawihna man tur pawisa a nei lova. Supreme Court chuan mi rethei in an chanvo tur ang retheihna avanga an chan theihloh chuan Art.21 a, an dikna (right) an tihbawrhbansak tihna a ni a. Chuvangin, heng Ukil rawihna tur pawisa nei ve zo lo te hi sawrkar chuan a thlawnin Ukil an rawihsak thin tur a ni tiin thu an thupek an chhuah ta hial a ni. Hemi chungchang pawh hi Directives Principles of State Policy hnuiaia Art. 39A ah tarlan tawh tho a ni a, mi hausa te leh rethei ber tena dikna tlantling an neih ve theihna tura ruahmanna a ni ber e.

Right to Bail:

Babu Singh v. State of U.P., Hemi case ah hian Supreme Court chuan misuala puha an man, pawisa hmanga chhuah lailawk sak theihna, (bail theihna chanvo) hi mi tupawh (Khua leh tui leh ramdang mite pawh) dikna a ni a. Kan phalsak lo a nih vaih chuan Art. 21 bawhchhiatna lian tak niin, na taka hrem theih an ni ang tiin thupek an chhuah a ni. Bail chungchang hi chu Mizo te paw'n kan hmelriat tha hle tawhin a hriat a. Amaherawhchu, bail kan nih hian kan thubuai chu a tawp ta e tihna ni lovin, kan thubui an ngaihtuah chhung chu ka zalen hrih e tihna chauh a ni a, heihi kan theihnghilh loh hram a tha.

Right against Handcuffing:

Kawl inbun tir hi mihring zahawmna leh hlutna tih bawrhban sakna lian taka anga ngaih a ni a. Prem Shankar v.

Delhi Administration, hemi case ah hian Supreme Court chuan misuala puh, mana awma chu a mantu te laka hriamhrei chelek mai thei dinhmuna awm a ni emaw, tlan bo thut thei dinhmuna ding emaw a nih ngawt loh chuan tumah hi kawl kan inbuntir ringawt tur a ni lo. Kan buntir a nih pawhin buntir a nih chhan a hriat lai ngeiin Magistrate hmaah kan hriattir thin tur a ni tiin thupek a chhuah a. Hei hi Court chuan a ngaipawimawh hle a ni. Kan ramah pawh misual nia an ngaih avanga an man, khawlaia kawl an buntir hmuh tur a awm fo a, police te hian Supreme Court thuchhuak hi an zawm ngei em tih hi zighthna awm thei tak a ni.

Right against Inhuman Treatment:

Kishore Singh v. State of Rajasthan, hemi case ah hian Supreme Court chuan tham lo leh zahpah lo taka an mi mante sawisak leh tawngkam mawi lo tak taka beih chiam hi mihring hlutna tihbawrhbansakna lian takin niin Art.21 bawhchhiatna lian tak a ni bawk a. Chuvangin, diriam takin tan ina awmte kan sawisa tur a ni lo tiin thupek an chhuah a ni. Tunhnai maiah pawh, police ten an mitang an sawisa hlum/na takin an hliam tih thawm hriat tur a tam khawp mai. Hemi thuah hian police te pawh kan fimkhur tlan hle a tha. Dan ang takin kan mitangte kan enkawl thin tur a ni a, dan pel baka kan che uchuak a nih vahzawngin, Art.21 kan bawhchhia tihna a ni a, hremna tuar tur a nep hauh lo ang le. Right to Damages for violation of Art. 21:

Art.21 ina mitinte dikna min pek hi hlamchhiah / ngaihthah a nih mai loh nan Court chuan tunhnai mai khan ruahmanna thar a siam a. Rudal Shah v. State of Bihar, hemi

case ah hian Supreme Court chuan Art.21 ina mitinte dikna chanvo a pek hlamchhiah avanga a tuartirtu tena pawisa an chawi a, a tuartu tena zangnadawmna an dawn theih turin ruahmanna thar a siam a, uluk takin a vil zui reng bawk a ni. Keini, mipuite ho pawh hian heng Art.21 ina dikna chanvo min pekte hi Court in min hum sak tlat tih hi hre reng ila. Kan chan tur ang kan chang lo a nih vah chuan zangnadawmna min pe thei a ni tih hre rengin, kan phak tawk theuhah dan hi i chik deuh deuh ang u.

Tin, heng zawng zawng bakah hian Art 25-28 kan chhiar chuan India khua leh tui tupawhin kan sakhaw duh zawng be tura zalenna kan neih thu kan hmu leh a. Hetia India Union chhunga him taka kan awm tawh hnua kan hnamzia a boral mai loh nana kan chibing hnamzia chawinung tura dikna leh duhsakna min pek hi a ropuiin a hlutzia thu leh hlain a puangchhuak zo mawlh lo a ni ber e.

Fundamental Duties:

Danpui (Constitution) a nih anga zawm leh a thu ken zah/ngaihsan leh zirtirna zah te, Hnam puanzar leh Hnam Hla zah te,

Ram ngaihdan/sukthlek ropui tak, chumi hmanga zalenna sualtir theitu zah leh chawisan te,

India ram inpumkhatna inlungualna leh amaha ro inrelna vawn nun leh humhim te,

Ram venhimna hnathawh leh chutiang thawk tura koh a niha tha leh zung pek te,



Heng mahni inchhungkhura tihdudhahna leh hnuaichhiahna tuar thinte hian hlauhthawhna vang leh zahna vang te in an tawrhna zawng zawng hi an sawichhuak ngam lo thin zawk a. Mi tam tak mahni pasalte lakah emaw mahni pasala nu leh pa te lakah emaw nekchepna tuar tam tak an la awm a. Chung tanpui ngaite tanpuina tur chuan he dan ‘Protection of Women from Domestic Violence Act, 2005’ pawh hi duan a ni.



Eng nge Domestic Violence chu?

Sec 3 of Protection of Women From Domestic Violence Act, 2005 hian Domestic Violence awmzia chu chiang takin a sawi a. Tawitēin sawi ta ila. Inchhûng khura uchuak tako intihduhdahna/hleilenna/inngaisakna/indiriamna tawngkam leh taksa-ah, tiin a sawi theih awm e. Hengte hi a tuartu ber chu hmeichhia an nih thin avangin he dan hian hmeichhia a tinzawn bik a ni.

Sec 3-nain a sawi dān chuan Domestic Violence chu:-

- Mihring taksaa innghaisakna:** Hei hian kut inthlâk, inhnek, invuak, inben, inpêt, innam, inchum leh kut inthlâkna dang dangte a huam.
- Mipat hmeichhiatna lama innghaisakna:** Hei hian mipat hmeichhiatna rawngkaia indiriamna, hmeichhiate zahawmna tihbawrhbân sak a kawk.
- Taksa leh rilru lama innghaisakna:** Tawngkam meinei tak te, inthamlohma tawngkam te, indiriamna tawngkam te, in auh leh koh nawmnah te, invau ang chite a huam a. Entiran: Fa inhrin sak theih loh mai avânga elsêne tak intawngkhum ang chi te.
- Eizawnna lama inhrêkbehna:** Hmeichhiate leh fate eizawnna intihtawp sak ang chi te hi.

A pawi khawp mai.

Hmeichhiate tana kan hriat theuh tur chu ‘Mizo Hmeichhe Insuihkhawm Pawl’ (MHIP) hi kan aiawha pawl ding, kan harsatna min sutkianpui tura pawl ding a ni a. Chuvangin, kan harsatna kan thlenna hmasa ber tur chu MHIP te hi an ni a tih loh theih loh. Kan veng chhunga MHIP hruaitute hnena kan harsatna te kan thlen vat ang a, anni chuan kan dikna leh chanvo hmuhlet lehna turin kawng min dapsak thin dawn a ni.

Chung bakah chuan, MHIP mai pawh ni lo, Kohhran leh Khawtlang hruaitute pawh hian mawhphirhna thui tak an nei a. Court chuan ven himna leh ham\hatna NASA tak min pe thei a ni. He dân hnuiah hian thubuai hi a tuartuin heng a hnuiah mite hnenah hian a thlen thei:-

- (1) Court (Judicial Magistrate First Class).
- (2) Police Officer-ah a thlen thei a ni.
- (3) Protection Officer.
- (4) Service Provider.

Protection officer leh Service provider-te hnênah i thlen a nih chuan, an ni hian Court thlengin i thubuai chu an theh luhpui ang che.

5. Court ah chuan eng ang venhimna nge kan dawn theih?

Chutianga Court-a thubuai (Complain) theh luh a nih chuan Magistrate chuan Order khauh tak a siam thei a, lehlam lehlam uluk taka a ngaihthlâk hnuah chu hmeichhia chuan Domestic Violence a tuar ngei nia a hriat chuan emaw, dinhmun hlauhawm tak Domestic Violence tuar mai thei dinhmunah a ding nia a hriat chuan; chu hmeichhia humhim nan chuan lehlam mi (Respondent) chu eng hleilenna (Domestic Violence act) mah ti lo tûrin thupêk pein a khap bur thei a ni.

- Chu hmeichhia(aggrieved person) awmna hmuna kal lo tûrin a tibur thei a, chu hmeichhe hna thawnha hmunah chuan kal lo tûr chuan a ti thei bawk.
- Tin, tihduhdahna tuartu(aggrieved person) kha naupang a nih chuan; a ni tin school kalna lamahte pawh lo va kal lo tûr thlengin a ti thei a ni.
- Kut thlâk lo tûr te, mawi lo taka tawngkhum lo tûr te, biak pawh be lo tûr te, Phone hmang pawha be miah lo tûr thlengin Respondent chu khapna thupêk a pe thei a ni.
- An bungraw intâwmte pawh lo tiriral lo tûr leh, an Bank Account intâwmte pawh lo khawih che miah lo tûr thlengin a ti thei.

- Thubuai neitupa (Respondent) emaw a chhûngte tupawh kha, kha hmeichhia Domestic violence tuartu awmna inchhûng khawilai emawah an luh ve a phal lo thei.
- Thubuai neitupa (Respondent) kha, kha hmeichhia nena an chêñ dun mêtka in kha lo tiral ngawt lo tûrin a ti thei.

Sec 20 Monetary Reliefs: Magistrate chuan:

inghahna lungphum pawh a la ni. Kan Lal te ban an niha mipui thlan lal, Village Council ten ram rorelna an lekkawh tirh pawh khan he NE Parry Customary Law phuahkhawm hi an inghahna hnar ber a ni a. Dan tawngkam takin 'Procedural Law' & 'Substantive Law' a ni pawh kan ti thei ang.

Chu NE Parry phuahkhawm chu District Council hunlai khan mumal zawka phuahkhawm leh remthat a ni a. Chumi hnu rei lo te ah Mizo Customary Law bika rokhawm dan chungchang bik chu 'Mizo District Inheritance of Property Act, 1956' ti-a legislate (dan duan) a ni a. Inneih leh inthen chungchangah erawh Mizo Customary tlawhchhan veka thubuai rem leh rel thin a ni a. Amaherawhchu, Ro khawm dan chungchangah bik erawh chuan 'Mizo District Inheritance of Property Act, 1956' anga rel a ni thin!

Chutia hun rei tak hman zui a nih tak hnuah ni 13.2.2015 khan Rokhawm chungchang mai ni lo, Inneih leh Inthen

chungchangah pawh dan siam a lo ni ve ta a. Chu chu ‘The Mizo Marriage, Divorce and Inheritance of Property Act, 2014’ tih a ni. He Dan thar hian ‘Mizo District Inheritance of Property Act, 1956’ chu a thiat a. Tin, Inneih leh Inthen chungchanga Mizo Customary Law kan behchhan thin pawh he Dan hiam a luahlan chho ta bawk a ni.

Chutihlaia kan hriat tur chu hetia Inneihna, Inthenna leh Rokhawmna chungchanga Dan bik a awm tak avang hian Mizo Customary Law chu a thiin awmzia a nei ta love tihna a ni chuang lova. Hemi Inneih, Inthen leh Rokhawm chungchang bik ni lo, thil dangah chuan Mizo Customary Law hi a ngai angin a la nung reng a, hman theih reng a la ni bawk!

He dān hian Mizoram District Council pathum: Lai, Chakma leh Mara Autonomous District Council-te a huam tel ve lo. Mizo zawng zawng tāna hman tûr niin hnam dang nena inneih pawlhna chungchāngah chuan a mipa zâwk chu Mizo a nih chuan he dān hi zawm leh hman tûr a ni. He dān hian ‘Mizo’ tih chu pian leh murna (by birth) avâṅga Mizo ni te, fa atâna lâk (adoption) avâṅga Mizo lo ni ta te leh mipui vantlāṅg leh khawtlâṅgin Mizo nia a pawm te hi a ni.

INNEIHNA (Marriage):

A tir lama kan sawi lan tak angin he Dan thar hi ziaka dahchhuah ni mah se, Mizo Customary Law behchhana duan vek tho a ni a. Chuvangin, kalphunga kan lo neih thin Mizo inneih sawngbawl dan leh man leh mual inhlau danah danglamna em em a awm hran chuang lova. A danglamna langsang ber chu Ziaka dahchhuaha, *legislate* a nihna hi a ni deuh ber!

Chutihlai erawh chuan a hmaa kan kalphung pangngai pela herrem leh khawih danglam hret hret a awm nual tho a. Chung zinga kan hriattur pawimawh langsar zualte chu han tarlang ila:

- Inneihna-a man/hmeichhe man (marriage price) chu Rs. 420/- aia tlêm lo a ni ang.
- Palaite kaltlanga ‘man’ pek chu ziaka chhinchhiah tûr a niin, copy hnih (2) siam tûr a ni. ‘Mo’ chhungkaw hotu lu ber (head of bride’s family), Man dawngtu leh palai ten hming an ziah hnan ang a, mipa lam leh mo lamin copy khat ve vein an kawl ang. Man chu man eitu hrang hrangte hnenah ‘man tang’ atana sem leh tûr a ni bawk.
- Inneihna vawngtu (Licensed Officer) hnenah innei tûrte chuan Inneih an duh thu chu an thlen ang a, Inneihna vawngtu chuan innei tûrte nêñ inrâwn tlângin Inneihna tûr hun leh ni leh hmun tûrte an ruat ang. Inneihna tûr hriattîrna chu Biak In-a hmun remchâng laiah târ tûr a ni a, Kohhran kalphung pangngai angin puan zar theih a ni bawk.
- Inneihna chu Licensed Officer-in a sâwngbawl (solemnize) ang. ‘Licensed Officer’ tih hian Kohhran hrang hrangte kalphung mil ang zêlin Ordained Officer/Reverend/Pastor/Kohhran Upa/Tirhkoh (Priest)/Ordained Priest te hi a huam ang. Inneihna chu inneihtirtu bâkah mi dang pahnialtin an hriatpui tûr a ni. Mo neitu thian leh Mo thiante hi hriatpuitu atana tling zo an ni. C ‘lnru’ emaw ‘tlan dun’ emaw,’ fan’ emaw, ‘luhkhung’ emaw te hi dân anga Inneihna a awm zui si /oh chuan Inneihna tling zo lo a ni ang. Mahni awmna Kohhran bil-in (religious denomination) nupui pasal atâna neih a phalsak loh (prohibit) te chu miin nupui pasalah a nei thei lo ang).
- Neih inang (same sex) awm dun te, nupui pasal nei reng chunga mi dang neih te, kum tling lo innei te emaw, tu

emaw zawk kum tling lo an nihin emaw Inneihna chu dān anga Inneihna (Marriage) tling zo lo a ni ang.

- Inneih Certificate (Marriage Certificate) chu Inneihna vawngtu (Licensed Officer) chuan a pe chhuak ang a, chu Certificate chu Inneihna nemnghettu a ni ang. Inneih Certificate-ah chuan he thu hi ziah lan tel ngei tûr a ni. - (iii) Kawppui laka nunrawnna lantîr vâng te, kawppui tihthlabâr vâng te, chêñ dun zui zêl hlauhawm khawptea a siamin;

- (iv) Thubuai theh luh hma-a kum 3 aia tlem lo, enkawl dam theih loh khawpa rilru lama rualban zawh lohna kawppuiin a neihin;

He dân hman a nih hma leh a hnu lama innei te rêng rêng, a chunga târlan tâk chhan leh vâng hrang hrangte avânga inthen duhte chuan Court-ah dân angin inthen dîlna an thlen thei a, thubuai ngaihtuah chhûng hi thla ruk (6) aia rei a ni tûr a ni lo. Inthenna thu (decree) thiat leh tura dîlna a awm chuan uluk taka ngaihtuah a nih hnuah Court chuan Inthenna thu (decree) a tihchhuah tawh chu a thiat (rescind) leh thei a ni.

Mi in a dam laiin Thurochhiah a siam a, amaherawhchu a siam dana kha a lo dik si loh chuan **Probate of Will** (Thurochhiah nemngheh) a nih dawn khan lo pawmpuilo tu an lo awm thei a, chutiang a nih chuan Thurochhiah neitu (Executor) khan buaina a tawk ve thei tlat a ni.

Thurochhiah siam tu (kum tling chin) chuan rilru fim tak puin a siam tur a ni a, Hriatpui tu kum tling pahnih tal an awm ngei ngei tur a ni. Thurochhiah siam tuin Hriatpui tu hmuh lai ngeiin a Thurochhiah ah hming a sign tur a ni a, a sign zawh ah Hriatpuituin rilru fim tak pu chungin Thurochhiah siamtu hmuh lai ngeiin an sign leh tur a ni. Tin, anmahni theuh paw`n an sign lai an in hmuh pui tur a ni bawk. An hming an sign hun, a hmun leh a ni te a in ang vek tur a ni tih pawh hriat tel a tha.

Thurochhiah hi a siamtu a thih atanga kum nga chhungin Civil Court-ah nemngheh tur a ni a, Thurochhiah nemngheh dawn hian pawmpuilo tu an awm theih avangin Hriatpuitu ruat/thlan ah pawh fimkhur a ngai hle. Thu dik tak chauh sawi thei tur a ni tih kan hriat chiante ngei chauh Hriatpuitu a hman a thain a him ber a ni.

PA RO KHÂWM CHUNGCHÂNG:

Thurochhiah a awm lo
a nih chuan a hnuia mi ang
hian bungrua chu inrochun a
ni ang:-

- (a) Chhungkaw pa ber a lo boralin ‘nu’ chu a thianghlim (chaste) chhûng leh kum tling lo fate a enkawl chhûng chuan chhûngkaw hotu (head of family) a ni nghal ang a, a faten kum an lo tlin erawh chuan a fate hnêñ atangin head of family ni tûrin ‘no objection’ a lâk a tûl thung.
- (b) Pa berin a boralsan bungruate chu fapa ‘indang lo’ ho leh ‘nu’ chuan a inzatin an inseñ ang. Fapa naupang ber chuan chhungkua a enkawl a nih chuan chanpual pakhatin a chang tam thung ang. - (c) Chhûngkaw pa ber boral hmain fapa, ‘A’ a lo boral a, chu mi hnuah pa ber lo boral ve leh ta se, pa ro chu fapa la dam, ‘indang’ lo te leh nu ber ten an inseñ ang a, ‘A’ chan ve tur chu pa ber boral laia an la indang lo a nih chuan ‘A’ a fate chuan an rochung ang. Fapa naupang ber chuan chanpual pakhatin a chang tam ang.
- (d) Pa ber chuan fapa nei lo ta se, rosum chu a nupui leh a fanu pasal la nei lo leh la indang lote chuan inzâtin an inseñ ang.
- (e) Pa ber boral laia fapate indang tawh an nih chuan rosum chu fanu pasal la nei lo te, nupui leh fapa la damte chuan an inseñ ang a, fapa naupang ber chuan chanpual



pakhatin a chang tam ang. Pa berin fa hmasa nei ta se, a fa hmasate chu pa kianga an chén bawk si chuan a pawm lai laka a fapa leh fanuten ro an khawm theihna ang chanvo hi an nei ve vek ang.

- (f) Pa chuan fapa nei lo se, a fanute pawh chuan pasal nei vek tawh se la, pa ber rosum chu nuin a rochung vek ang.
- (g) Hmeichhia hlir nei se, chung chuan pasal nei tawh se, nu ber awm lo ta bawk sela, pa rosum chu pasal nei tawh fanute chuan inzâtin an inseum ang. h) Fanu emaw, fapa emaw nei lo se, nupui pawh chu pa ber boral hmaa a lo boral tawh chuan rosum chu a nupui hmasa faten an rochung ang. A nupui hmasa chuan rochung turin chanvo a nei lo thung a, a chanvo tur ang chu a fapa naupang berin a chang thung ang.
- (i) Fapa leh fanu nei lo, nupui nei tawh bawk si lo a nih chuan pa ber rosum chu hmeichhe dang laka a fanu (illegitimate daughter) chuan a rochung ang a, chutiang fa a nei lo a nih chuan pa ber boral ta unauten an rochung thung ang a, a unaupa te zînga a naupang ber chuan chanpual pakhatin a chang tarn ang.
- (j) Fapa kawppui nei lo, fa nei bawk si lo chu a pa kianga a awm laiin a lo boral a nih chuan a rosum chu a pa chuan a rochung ang a, a pa a lo boral tawh a nih chuan nu berin a chang thung ang. A nu leh pate chu an boral tawh a nih chuan a unaupate zînga naupang berin a rochung ang a, unau mipa a nei lo a nih chuan a unaunute zînga naupang berin a rochung ang a, sâwn a lo nei a nih a, sâwn man a pêk bawk chuan a sâwn (mipa) chuan rosum a rochung ang a, sâwn chu mipa a nih loh pawhin hmeichhia (sâwn) chuan a rochung ang.
- (k) Fanu kawppui la nei lo, fa nei bawk si lo chu a pa kianga a awm laia boral a nih chuan rosum chu a pa chuan a

rochung ang a, a pa a lo boral tawh chuan a nuin a rochung thung ang. A nu leh patean boral tawh a nih chuan a nuta zinga naupang berin a rochung ang a, nuta a neih loh erawh chuan a laizawn zinga naupang berin rosum chu a rochung ang. Sâwn a lo pawm a nih hlauh erawh chuan a sâwn mipa fa zâwk chuan a rochung ang a, a fa chu mipa an awm lo a nih erawh chuan hmeichhiain a rochung thung ang a, mipa hnen aṭangin sâwn man erawh a dawn loh a tûl thung.

(l) Inchhungkhurah ‘Falak’ an awm chuan a nu chanvo rochung turin chanvo a nei ang.

ROKHÂWM CHUNGCHÂNGA HRIAT TÛR PAWIMAWHTE:

- (i) Fapa indang tawh leh fanu pasal nei tawh chuan a chunga tarlan dan ang lo khi chuan ro an khâwm thei lo ang a, hnathawhna avâng emaw chauha khaw dang leh ram danga awmte chu indang anga ngaih an ni lo thung.
- (ii) Pasal nei tawh, inthenna avânga pa emaw, nu emaw hnena kîr leh chu rokhâwm chungchângah chuan fanu pasal nei lo anga chanvo pêk a ni ang.
- (iii) Nu a lo boral chuan a rosum chu a pasalin a rochung ang a, a pasal a awm tawh lo a nih chuan pa ro khawm dân kalphung ang chiah khan rosum chu inrochun a ni ang.
- (iv) Miin a boral hmain a duh dân ang ngeia amah enkawltu a neih chuan, rokhawm chungchângahhung ang.
- (v) Faten pa ro chungchângah an chanvo la mahse, nu ber chu hmeithai thianghlim (chaste widow) a nih chhûng chuan inchhûngkhur leh a chhehvêl luah lum thei tûrin dikna chanvo a nei thung a ni.

COURT THUNEIHNA:

He dâñ hnuiai thubuai rêng rêng chu heng a hnuiai sawi thuneihna (Jurisdiction) nei Court eng emaw berah thehluh theih a ni. Chungte chu:

- (1) Inneih buatsaihna (solemnize) hmun emaw
- (2) Thubuai thehlüttu ni lo zâwk (Respondent) chênná hmun emaw
- (3) Nupa chén dunna hnuhnung ber.

He dâñ hnuiai thubuai ngaihtuahtu Court chuan nupa inkarah inremna a awm leh theih nan theihtawp a chhuah hmasa phawt tur a ni. A tûl dâñ anga palai hna thawk tûrin Court chuan mi dang pawh a ruat thei ang. Chutih chhûng chuan thubuai ngaihtuah tûr chu a sawn hla (adjourn) thei ang a, amaherawh-chu thla hnîh (2) aia rei tiakhawtlai loh tûr a ni. Thubuai ngaihtuahtu Court-in thutlûkna a siamin a copy chu a thlawnin inkhingte hnênah a pe ve tûr a ni ang.
