**THE LUSHAI HILLS DISTRICT (VILLAGE COUNCILS) ACT, 1953**  
**(Lushai Hills Act. No. V of 1953)**

He Village Council dan hi Sixth Schedule to the Constitution of India, Paragraph 3, Sub – para (1), Clauses (e) & (f)-in thuneihna a pek hmanga kum 1953-a Lushai Hills District Council-in a siam a ni a, ni 29.11.1953 niin Governor of Assam pawmpuina (assent) lak a ni a. Tichuan, Assam Sorkara Tribal Areas Department-in Notification No. TAD/R/61/52 Dated 1<sup>st</sup> Dec., 1953 hmangin chu Dan chu a chhuah (published) ta a,chu chu Assam gazette Dated 9<sup>th</sup> Dec., 1953-ah chhuah a ni. He Dan hi khua (Village)-a Village Council siam dan Member zat, member atana thlan theih, Executive siam dan, hnatlang chungchang, V/C rorel hmangchang, V/C thiah, khawper din leh V/C chungchanga thil pawimawh dang tam tak chuanna ber a ni.

- (2) Village Council chuan Secretary a nei ang a, chu chu Executive Body thurawn angin Sorkarin a ruat (appoint) thei a, a ban (dismiss) thei bawk.
- (3) Secretary chu Village Council member a ni tur a ni lo a, President leh Vice President pawhin Secretary hna chu an chelh thei lo.

- (4) President chuan eng hunah pawh President a nihna aṭanga ban a duh chuan, a banna chu ama kut ngeia ziakin Sorkarah a theh lut tur a ni a, a banna chu pawm anih hma chuan a thawk chhun zawm ang.
- (5) Vice President pawhin a duh chuan ama kut ziak ngeiin a banna chu President hnenah eng hunah pawh a thehlut thei a, ani chuan chelh khawtlai loin Sorkar hnenah emaw, sorkar ruat Officer hnenah emaw a thawn ang. Dan tlangpuuin banna chu pawm a ni ḫin ang. Chuti anga a banna pawm anih chuan member-ten anmahni zing aṭangin Vice President chu an thlang leh ang.
- (6) President leh Vice President ni lo member tupawhin ban a duh chuan a banna chu ama kut ziak ngeiin President hnenah emaw , President awmloh lai chuan Vice President hnenah a thehlut anga , ani chuan tikhawtlai loin Sorkar-ah emaw, Sorkar ruat Officer hnenah pawm turin a thawn ang. A banna pawm anih hma chuan a thawk zawm ang. Dan tlangpuuin chutiang banna chu pawm a ni ang.
- (7) Eng hunah pawh, eng vang pawha Village Council seat ruak a awm chuan President emaw Vice President emaw chuan Sorkar-ah a report thuai tur a ni a, Sorkarin seat ruakah a puang ang.
- (8) Eng vang pawha President hmun alo ruah chuan a rang thei ang bera hnawh khat turin Sorkar-in hma a la ang a. Chutih chhung chuan President hna chu Vice-President in a lo thawk ang.
- (8-A) President, Vice-President leh member-te chuan Sorkar bithliah zat lawmmman leh thil dang (renumeration and privileges) an dawng ang.
- (9) Village Council President, Vice President, member leh Secretary-te chu Indian Penal Code Section 21-na hnuaiah Public Servant-a chhiar an ni.

- (10) President emaw, Vice President emaw chu member tam zawk thlawpna nei tawh lo chung a mahni inhnuvdawk duh lo anihin emaw, mahni hna zolo leh hlem hle, Khawtlang rorelna keng tlak lo nia Sorkar-in angaih emaw, ram tana khawlkhham siam zawnga che nia a ngaih chuan Sorkar-in a paikh (remove) thei.
- (11) President chu member tam zawk thlawpna nei tawh lo a ni a, Sorkar-a ziaka thlen anih chuan Sorkar mi ruat officer-in President thar thlang turin meeting a ko ang. Sorkar mi ruat chuan meeting neih hun leh hmun ruatin hriattirna a chhuah ang a, hriattirna copy khat sorkar-ah a thehlut ang. Chu meeting chu sorkar ruat (official) in a kaihruai ang. President thar thlan chungchang chu sorkar-ah theh luh nghal tur a ni ang.

- (4) Village Council hnathawh leh Village Council meeting-a thutlukna reng reng Gram Sabha a sawifiah leh hriattir chu an mawphphurhna a ni ang.

(5) Village Council-te chuan sorkar-in form siam hmangin khawtlang tana an hmalaknate kum khatah vawi hnih sorkarah an thlehlut thin ang a. Report hi thehluh a nih loh chuan sorkarin sum (grants) leh lawmman Village Council-te hnena pek tur an hrensak thei ang.



## AGRONOMIC PRACTICES

Loneih dan chi hrang hrang hmag a leilung humhalh leh hlawk zawk a thlai thar theihna tur a hmalakna hi conservation farming emaw advanced agronomical methods vuah a ni.

- Agronomic practices hrang hrangte chu :
- 1) Contour farming.
- 2) Leileh dan dik leh hun eng emaw chen chhung a thlai ching lova ram dah awl.
- 3) Crop rotation, be lam chi thlai chin leh mixed cropping.
- 4) Mulching.
- 5) Strip cropping.

1) **Contour farming** : Tlangram awihtlanah te hman ani a, heng hmunah te hian ruahui leiah lut a tlem em em a, tuihawkah a luangral mai thin. Tlang/awihpang vang tan zawng a leiletin, khuar leh chhun pawn inkarthlak contour line zulzui a siam a thlai chin thin ani. Hei hian ruahui luangral mai tur chu lo dangin leiah a luanluh tir a, ruahui luang chak lutuk tur a lo dang thin.

Ram awihtlan vangtan zawng a a kual a thlai chin hian lei luangral tur nasa takin a veng a ni. Contour farminghian ruahui luangral a titlem a, lei luangral tur a venga, tin, buh leh bal thar chhuah a tipung bawk a ni.

### 2) **Leileh dan dik leh thlai ching lova ram dah awl**

- Lei hi thuk tak a leh nge tha a pawnlawi tak a leh ti ah hian inhnialna a tam hle a. Mithiam tam tak chuan ruahui tlemna hmun a pawnlawi deuh a leileh hian thlai thar a hlawk zawkin, hnim a tlem phah a lein tui a hip hnem zawk an ti. Lei thuk taka leh hian lei aluan ral tir hma zawk a. Amaherawh chu ruahui tlak tamna ramah chuan 15-30 cm a thuk a leileh hianin hnime to a titlem a, thlai thar a hlawk zawk a ni.

- Thlai ching lova hun eng emaw chen ram dah awl a chulai hmun a ran an tlat hian hun eng emaw ti hnuah lei a lo tha leh thin. He thil hi ruahmanna tha tak anih rualin mihring tamna India ram angah te hi chuan a hman theih loh a, mihring tamna ram kan nih avang hian chaw mamawhna a sang em em a, thlai ching lova ram dah awl mai mai chu kan tlin hrigh lo a ni.

### **3) Crop rotation, be lam chi thlai chin leh Mixed cropping :**

Fertilizer te nen enkawl mah ila a titha zotawh lova,a tawp ah chuan erosion a thleng mai thin. Thlai chin thlak kual hian leichhe tur a veng a thlai tharchhuah a hlawk bawk. Kumhnih danah zel lo a thlai chinte hi a chi thlak thin tur ani.
- Thlai chi kan thlak kual dawn a kan ngaihtuah hmasak turte chu – sik leh sa, sum leh pai dinhmun, leilung pianhmang, ram awih zawng leh leilung luanral dan te ani. Lei a zungkaih thuk chi thlaite chu a dawtah zungkaih thuk lo chi thlai a thlak tur ani.
- Be lam chi thlai ho hian lei a nitrogen siamna kawngah tha an thawh hlawk hle a. An zung a bacteria hrik awmte hian boruak a nitrogen awm chu nitrogenous compounds ah a siam a, chungte chu nitrates, nitrites, ammonium salts, amino acids leh protein te an ni. emaw a thlai chin pakhat kha a hlawhtlin loh palh pawhin thlai chi dang kan chinte atang khan hlawkna tel tur ala awm thei a ni.

**4) MULCHING:** Buhpawl emaw hnime hnah emaw plastic emaw a lei khuh hi mulching chu a ni. Soil erosion a veng a, lei a titha a, lei a hnawng awm rei tak a vawnghim bawk thin. Tin,lei a tuilut a titam a hnime to tur a dipdal bawk. Mulching tihna atan hian kan hmanna hmun a awm remchang apiang hman mai tur ani.

**5) STRIP CROPPING:** Lei leh hnawng humhalhna kawng a loneih dan tha tak mai ani. Erosion siamtu thlai leh erosion vengtu thlai te chu inkarthlakin ram awih lutuk lovah an ching thin.
