


Azadi Ka Amrit Mahotsav (India@75) : Contribution of Mahatma Gandhi NREGA in promoting Agriculture & Allied Activities

MGNREGA hnuiah hian hnathawh phal bik dan in a siamsa chi hrang hrang a awm a, thingtlang mi, kut hna mawl thawk thei te tan anih ang in, thingtlang a cheng mi tam zawk te eizawnna, kuthnathawh/huan lo ram enkawl hi a dah pawimawh em em a ni. MGNREGA hnuiai pawm theih hna te hi chi li (4) a then an ni a, hetiang in : Category A, B,C, D.

Hnathawh theih te hi hlawm 262 a awm a, chung zing a hna 164 chu thlai chin lam (agriculture) leh a kaihhnawihte an ni. Hei hian thingtlang mipuite tan MGNREGA hmanga agriculture lam a hmasawn tir a tum hle tih a tichiang. MGNREGA dan Sub para (2) of Para 4 of Schedule 1 ah chuan ti hian a inziak a: "District programme Coordinator chuan district chhunga hna thawh a man atanga chhuta 60% chu thlai chin lam tih hlawkna tur bik liau liau atan a ni tih a tichiang ngei tur a ni a, ram leh tui leh thing te pawh a hlawk thei ang ber tura chei bawl tur a ni," tiin. Nun khawchhuahna tur a ni ang tih beiseina lian tak nen hmun hrang hrang atanga hna ruahmannna lo kal te chu mimal hlawkna awm thei chi a nih chuan ngaih pawimawh bik tur a ni.



Hna then hrang hrang Category ABCD huamchhung a Agriculture kaihhnawih te lo en dawn ila:

CATEGORY A (Ram, leilung, thing leh mau enkawlna lam kaihhnawih (Natural Resource Management) Tui leh tuihna humhalh, tui khuah, leilung lung ral tur venna, tui hna tam theihna lam hawi, terrace, contour bunds, boulder checks te, gabion structure etc. Micro leh minor irrigation, tui lakna kawng leh tui hawk luan kawr chei that leh chei bawl. Tuikhur chei that te, tui lakna kawng leh tui awmna hmun chei that. Thing phun : mimal leh vantlang hmun ah. Tuipui leh lui kam a thlai chin uar. Thlai kum hlun hmun siam te, ram buaah lei tih thatna tur hna thawh te, Ranchaw lam chi chin na hmun siam.

CATEGORY B (*Mimal/ Chhungkua leh Vantlang tana eizawwnna rotling*)

Thlai thar chhuah hlawk zawk na tur a ram sawngbawl, tui lakna/chhek khawlna tih changtlun. Thlai chin, pangang vulh leh huan siam te leh huan hlun siam (horticulture & sericulture) chul ram leh thlawhbaw ram chei that leh a, ran chaw thlai leh hnime adangte chin nana hman (mimal ramah) ran vulhna tichangtlung tura hmun hma (infrastructure) ar in te, kel in te, vawk in te leh bawng in te, leh a chaw pekna te tha taka siam. Sangha khawi, sangha dah thatna hmun, vantlang rama fur tui tlinna hmuna sangha dah te (vantlang tan) mau, thelret, coconut chin.

CATEGORY C (*Common infrastructure including for NRLM compliant self-help groups*) Thlai thar chhuah a lo hlawk zawk theihna tur atana bio-fertilizer siamna hmunhma nghet (NADEP and Vermi-composting pit) siam leh thlai thar hnua a mamawh hmun, thlai thar dah khawmna in siam/sak.

CATEGORY D (*Rural Infrastructure*) National Food Security Act (2013) tih hlawhtlinna tur atana thlai thar/thlai chi dah khawmna tur hmun siam.
